## Dear Friends,

Some retirees are eager to get back to in person gatherings, but many have health issues that make that unwise or impossible.

We would welcome your thoughts about how we might best serve you as we reinvent many of our ministries. (If you happen to be the child of a retiree, you can also contact us.) Given where you are in your life as a retiree, what are the ways we might serve you in this new normal? Feel free to contact me or any of our Board members. We especially invite you to contact Haniel Garabay, who was hired last fall to assist us with programming.

Another thing is that the RCA will be getting a new president on July 1. My two-year term will be up. I guess I was the "Covid president"! Taking over will be Sandy Roberts, surviving spouse of Frank Roberts. Sandy has good past experience with the RCA Board and I'm looking forward to her leadership.

God IS doing a new thing! May we be able to open our eyes and hearts to it.

### **2022 Scholarship Awards**

The Retired Clergy Association [RCA], as part of our purpose "to strengthen our relationship with our Conference and to continue to be of service to the church and the world," award Memorial Scholarships each year. This year RCA will award three \$1600 Memorial Scholarships to students who are Certified Candidates and working either toward Local Pastors License and/or Ordination. The monies for the scholarships come from funds received as Memorials when Clergy or their Spouses die, and for each death the RCA also puts a specific amount into the Memorial Scholarship Fund.

Recipients of the Memorial Scholarships are for those attending Seminary or Course of Study, an alternative to seminary. The Scholarships also support Licensing School.



Vaitafa Heimolana is currently not appointed, and is doing Tongan Ministry at Stockton Holy Cross UMC. He is attending Claremont School of Theology for a Doctor of Ministry Degree.

### **Passing the Mantle!**

This article is especially for those of you who are looking for ways to pass on to others ministry resources that you have, but are not using in retirement! RCA calls this "Passing the Mantle!" after the Biblical story of Elijah passing his mantle on to Elisha.

Since we are meeting in person this year for Annual Conference, the items suggested below could be brought to Sacramento, as long as you understand that if they are not taken, you will take them back home with you. It is the assumption that these items will be GIVEN to, not paid by, the recipient/s.

Items to be considered follow, with suggestions.

If you have crosses you have worn, our candidates for ministry and local pastors can use those as they serve. You are welcome to ship those to me, and we will offer them to those awarded our Scholarships at our Annual Luncheon.

If you have stoles, it is only Elders and Deacons that can use those, so see who is recently or newly ordained and reach out to them directly. We will try to again have an announcement during Clergy Session that items are available, with a place to meet at the end of the session for the gifting.

Robes are much more difficult to share, as if you do, you need to spot someone that is the same size as you, and inquire if they are interested in robes.

Both younger and mid-career clergy who are still trying to pay for seminary or course of study are very appreciative of the following items that can get pricey:

Concordances, Biblical Maps

- Sets of Interpreter's Bible or other sets of Commentaries.
- Various versions/translations of the Bible
- Current Books of Worship
- Current Hymnals or other song books
- Current UMC Book of Discipline and UMC Book of Resolutions
- "Pocket Size" Book of Rituals
- Visitation Communion Sets

We also have been made aware of needs in seminaries in other countries: Philippines, East Timor, Tonga to name some recent ones. There may be other countries!
