MY FRIEND JEANETTE

I would like to introduce you to my friend Jeanette who was born in Rotterdam ten years before the start of WWII. She came from a large loving family. When the war started her family took in two Jewish boys who lived in their attic.

One evening just before Christmas early in the war the whole family, including the two boys, were gathered around the piano singing Christmas carols when they heard a knock on the door. The Jewish boys quickly made their way up the stairs to the attic while Jeanette's mother opened the door. Standing there were two Nazi soldiers. Everyone stood still afraid of what was going to happen.

One of the soldiers said as they passed the house they could hear the Christmas music and it reminded them of home. Jeanette's father invited them to come in and join the singing. They stayed for a long time singing and sharing Christmas stories. As they left they thanked the family for their hospitality and wished them a Merry Christmas.

Jeanette related this story to me one Sunday as I was taking her home from church. She was a wonderful lady with a warm smile that would make any heart melt. I asked her how she could be so happy after living through the war. It is then that she gave me the advice for a happy life... Keep smiling. I'm always surprised at what a smile can do because there are people who are always grumpy and if you keep smiling at them, sooner or later you'll get a little smile back.

Surround yourself with nice people. Keep looking until you find them. Don't be grumpy yourself because nobody will want to talk to you. Be interested in people so you can talk to them. Keep your eyes open for people who think like you do. Have a good sense of humor. Laugh a lot.

Be with people. There's nothing worse than being alone. You don't have to be good friends with everybody and it doesn't have to be huggy or cozy but we know we are there for each other.

Have somebody who loves who you are so there are a lot of laughs. That's what Jake, her husband, and I did.

If you can sing songs, that's the best thing you can do...children's songs, hymns, long ago songs. We were a happy family and, oh boy, did we ever sing a lot. Listening to music you can feel it wash over you.

You need to trust people. You have to trust people, you need to trust. Always try not to judge. Look for the better things. Let go of the things that hurt you that you can't change. Don't think about them.

I've been lucky to have good friends, to have had a good job and my family. I was lucky I found my husband out of 19 men who worked in our office and he chose me. The other men came to our wedding. I have no regrets.

Thank you Jeanette for all your good advice. I hope you all can find it as helpful as I have.


2022 VIM WORK PROJECT

For the first time since Covid, RCA sponsored a work project. Oct 2-7 seven RCA members, joined by 4 Endowment board staff and 4 Habitat for Humanity volunteers labored on three homes in Paradise, CA. burned to the ground four years ago. The non-profit Hope Crisis Response Network sponsored our work out of Middletown for several years and has established a volunteer presence in Paradise. New homes are financed by CalHome loans and volunteer hours make it possible for the complete home to be built within the \$150,000.

During the week we shared worship in the

Paradise UMC sanctuary which just survived the fire. We were led by work camp participant

Bob Chicou who was pastor of the church at the time of the fire. Tearfully and prayerfully we heard

Thoughts on a Retirement

I have for some years thought of the Gospel story of the rich young ruler (Mark 10:17-31) as my story. As part of a guided retreat that came not a moment too soon in a time of crisis, a spiritual director offered me this text, reminded me that my assignment was to meditate on it, not preach it, and sent me out to spend the next 24 hours in silence.

I found in that story something I had never seen there before: myself. I saw myself in the character named 'rich young ruler' who– even in his sadness–loved the picture of his life too much to trade it in for the simplicity of Jesus' calling. I saw myself in the 'I can't' response of this young man; and the dismayed, knowing look that



must have crossed Jesus' face as he walked away. I saw myself-thanks be for grace-in the sentence "Jesus looked at him and loved him."

I have--of course, because I am a preacher-used that story many times in my ministry. I've asked people to think of it as a story not about wealth but about identity. I think maybe what kept that earnest young man from following Jesus wasn't his wealth, but the self-image that rested on the scaffolding of his possessions. And so, I've asked, what is the familiar identity that makes us feel rich, and that keeps us from seeing in ourselves a poorness of spirit that would welcome salvation?

And now, just a few months into retirement, I am wondering about another ending to this story. What if the rich young ruler had done as Jesus suggested? What if he had, as he sold his many possessions and gave away all the money, and felt good about it, come back to join the throng of Jesus-followers? Would he have felt immediately unburdened? Would every day have felt full of good work, transformation, the joy of a compassionate life? Or would there be days when he still wondered, "Who am I, now that I am not the 'rich young ruler'? What is my name in the Gospel that is being written now?"

In the rule of life I have constructed to guide me through these days when I'm learning to measure my value by something other than productivity, I have included an element that is simply 'Give yourself away for others.' I realize now how much I relied on my work as a pastor to do that–pretty much every day. That was the joy of ministry for me. That is the loss that stings.

What did you feel in those first days after you gave up the name 'Pastor'? What is the identity that holds you now? Is there a place-or need-for a conversation about this?
