

IT'S THE HATE THAT'S THE SIN

CONTEXT: A baby believer who proclaims himself born again asked how a preacher could call someone a "Child of God" when the unhoused person this preacher was ministering to, had not "accepted Jesus Christ as their Lord and Savior"...to paraphrase.

This was my response: (and what I believe on that topic)

I understand you are coming from a faith tradition that you understand requires you to do certain steps to become a Christian and enter the kingdom of heaven.

However, others of us believe that when God created humans he created all of them. I go no further than Genesis 1:27 (and I'll use the KJV because so many think it is the only valid version even though it is the version that King James created to keep his power...but I digress) "So God created man in his own image, in the image of God created he him: male and female created he them." If you'll note, there is neither exception nor gendering of God. God, in this verse, is both male and female. The International Standard Version makes that even more plain: So God created mankind in his own image; in his own image God created them; he created them male and female. But what about John 14:6? you say. Excellent question. But no one verse exists in a vacuum. The entire chapter speaks of Jesus as being part of God and God is a part of him. Because if you keep reading...John 14-7 If you really know me, you will know my Father as well. From now on, you do know him and have seen him." This chapter isn't talking about a prescription into heaven, but rather how do the disciples know that they are seeing God. The Son is telling them, they have. And that the words the Son speaks are the words of God. So follow the Son and you follow God.

Further along, he sets up the idea that the Son will go away, but will return. No doubt the disciples believe this to be a physical going away as on a trip, but we know (in the beauty of hindsight) he means he will die and come again.

In the next chapter we get John 15:13 that gives us the command to love one another as Christ has loved us. And then John 15:17 This is my command: Love each other.

This then leads directly into John 15:18-23 where on first reading it sounds like those who hate Christ are condemned. But if you read it IN CONTEXT, it's saying that followers will be hated for following the commandment of John 15:17. Loving each other is the REASON for the hate. In Christ's time, loving "the other" simply for being was radical. It was dangerous. (what if they were an enemy!?) And if you did so, you were violating the societal norms of the time. (I'd say one still is violating the societal norms if you love others without reservation or condition)

It's the HATE that is the sin. It is the HATE that separates us from God. It isn't that Jesus is the key holder... it is that he has made it clear the way to God, to heaven if you wish. It is available to anyone who loves the children of God without condition. When you FAIL to do that, you have failed to learn the teachings of Christ and your sin of hate will keep you separate.

It will not rely solely on baptism. It will not solely rely on belief. It will not solely rely on what pew in which building you are on

Sundays.

You simply have to follow the commandment, spoken by Jesus, but are the words of God... Love one another.

Don't Get Scammed! Be Aware!

There are several different types of scams that are used to target everyone, but some are targeted especially to older people. Being aware these exist is the first step in staying safe.

Romance Scams

As more people turn to online dating, con artists are seizing the opportunity. Romance scammers create elaborate fake profiles, often on social media, and exploit older adults' loneliness to get money. In some cases, these scammers may be (or pretend to be) overseas. They may request money to pay for visas, medical emergencies, and travel expenses to come visit the U.S. Since they tend to drag on for a long time, romance scams (also called sweetheart scams) can bilk an older person out of substantial funds. The FTC found that 2022 alone, nearly 70,000 people reported a romance scam, with reported losses reaching \$1.3 billion.3 Get tips for avoiding sweetheart scams: https:// www.ncoa.org/article/sweetheartscams-how-to-avoid-being-avictim

Business Imposter Scams

The FTC has found this type of scam takes a heavy financial toll on consumers age 60 and older.⁴ Imposter scammers pretend to be

use of cryptocurrency (digital assets, such as Bitcoin) is common in investment scams.

Cryptocurrency investment fraud losses rose from \$907 million in

2021 to \$2.57 billion in 2022–a massive increase of 183%.¹

from a business or a charity. As described on USA.gov, business imposters "want you to trust them so they can steal your personal information and money."
Like government imposter scammers, business imposter scammers can use caller ID to trick someone into thinking they are getting an official business call. These fraudsters will try to convince someone to send money or a gift card or share personal information.

Investment Scams

This type of scam involves the illegal or alleged sale of financial instruments that typically offer low risk and guaranteed returns. The

Medicare and Health Insurance Scams

Every U.S. citizen or permanent resident over age 65 qualifies for Medicare, making the program a prime tool for fraud. In Medicare scams, con artists may pose as a Medicare representative to get older adults to share their personal information. Scammers might also provide bogus services for older people at makeshift mobile clinics, then bill Medicare and pocket the money. Medicare scams often

follow the latest trends in medical

research, such as genetic testing.

The slower rate of technology adoption among some older people makes them easier targets for internet and email scams. Popup browser windows that look like anti-virus software can fool users into either downloading a fake anti-virus program (at a substantial cost) or an actual virus that

exposes information on the user's computer to scammers. Their unfamiliarity with the less visible aspects of browsing the web (firewalls and built-in virus protection, for example) makes older adults especially vulnerable to such traps.

Phishing emails and text messages may appear to be from a well-known bank, credit card company, or online store. They request an older adult's personal data, such as a log-in or Social Security number, to verify that person's account, or they ask the older adult to update their credit card info. Then, they use that information to steal money or more personal information. Find out how to protect yourself against phishing scams:

Scams are specially designed to catch us off guard, and they can happen to anyone. There's *nothing* to be ashamed of if you think it's happened to you. Keep handy the phone numbers of resources that can help, including the local police, your bank (if money has been taken from your accounts), and Adult Protective Services: https://eldercare.acl.gov/Public/Index.aspx

"It's a heartbreaking fact that scams have wiped out people's retirement savings," said Lois Greisman, Associate Director, Division of Marketing Practices at the FTC. "If a business, government agency, or even a grandchild in need contacts you, it's critical to check who you're really dealing with.

Never panic or react quickly. Contact them at a number you know is real to verify."
